

Created Workshop - Commercial Use License

Thank you for choosing a Created Workshop design for your business! We love supporting fellow makers. This Commercial Use License grants you the legal right to create and sell physical products from our digital files.

By purchasing this license (either as a standalone product or as part of "The Craftsman" subscription), you ("the Licensee") agree to the following terms:

1. Summary of License

- **Licensors:** Created Workshop ([Your Website])
- **File:** The specific digital design file(s) (e.g., SVG, DXF, LBRN2) associated with this license.
- **Allowed Use:** Creation and sale of **physical products**.
- **Prohibited Use:** Any resale, sharing, or distribution of the **digital file**.

2. Grant of Commercial License

We grant you a non-exclusive, non-transferable, worldwide license to use the File to create and sell an unlimited number of **physical products**.

Examples of permitted commercial use include, but are not limited to:

- Creating wooden signs, acrylic ornaments, or leather patches to sell online or at craft fairs.
- Making coaster sets, game boards, or home decor items to sell in a retail shop.
- Engraving the design onto products for a customer.

3. Restrictions and Limitations

While you are free to sell the physical items you make, this license has important restrictions regarding the **digital file itself**:

- **No Resale or Distribution of the Digital File:** You may **not** sell, share, trade, copy, or distribute the digital File in any way. Please direct others to our website to acquire their own license.
- **No "Print-on-Demand" Use:** You may not upload the File to any print-on-demand or third-party fulfillment websites (e.g., Printful, Redbubble, Zazzle).
- **No Use in Logos or Branding:** You may not use this design as part of a business logo, trademark, or branding identity.

- **No Modification for Resale:** You may not modify, alter, or trace the design to create a new digital file that you intend to sell or distribute. The license does not grant you ownership of the design, only the right to use it.

4. License Duration & Terms

The duration of your commercial license depends on how it was acquired:

- **For Individual File License Purchases:** If you purchased this license for a single file, your license is **perpetual**. You can continue selling physical products made from that specific file indefinitely.
- **For "The Craftsman" Subscribers:** Your license to create and sell physical products using our files is valid **only while your "The Craftsman" subscription is active**. If you cancel your subscription, you may sell any existing physical inventory you have already created, but you may **not** create new products for sale using the files.

5. Intellectual Property & Ownership

Your purchase grants you a license to use the File as outlined above; it does not transfer the copyright or ownership of the design. All rights, title, and interest in the digital File remain the exclusive property of Created Workshop.

6. Termination

This license is terminated immediately if you breach any of its terms. For subscribers, the license also terminates if your subscription payment fails or is cancelled. Upon termination, you must cease all new commercial production using the File.
